POSITION OVERVIEW:

The Nutrition Specialist will play a key role in ensuring that all nutrition-related components of the Early Childhood Education and Assistance Program (ECEAP) are met for YES For Early Success. This position is critical in supporting the development and implementation of culturally responsive nutrition programs that promote the health and well-being of children and families. The contract is for an 8-month period, from October 1, 2024, through May 31, 2025.

Key Responsibilities:

1. NUTRITIONAL PLANNING AND COMPLIANCE

- Oversee the implementation of nutrition plans in alignment with the 2024-2025 ECEAP Performance Standards.
- Ensure that all meals and snacks provided are nutritious, balanced, and adhere to state and federal dietary guidelines, through monthly data collection.
- Monitor compliance with CACFP regulations and other relevant standards.

- Create and deliver culturally relevant nutrition education programs for children, families, and staff, upon subcontractor request.
- Collaborate with families and community partners to incorporate traditional and culturally significant foods into meal plans.

3. CHILD AND FAMILY ENGAGEMENT

- Engage with Regional Director to understand and incorporate their nutritional preferences and needs.
- Provide nutrition counseling and support for families as needed, through regional support (i.e. WIC/Food Banks/other referrals of food support programs)

4. COLLABORATION AND PARTNERSHIP BUILDING

- Collaborate with Regional Directors, Family Support staff, and community partners to integrate nutrition with other areas of child development.
- Build partnerships with local food providers to source fresh and culturally appropriate foods.

5. ENROLLMENT IN FOOD PROGRAMS

- Ensure that all subcontractors are enrolled in the Parachute Food Program and/or USDA food site for monthly collection of menus.
- Provide necessary enrollment resources, such as the USDA Food Programs link; area Food Programs.

- Experience in early childhood nutrition and knowledge of state and federal nutrition guidelines, including CACFP.
- Strong understanding of cultural competence in nutrition services.

 Terms: This is an 8-month contract position starting on October 1, 2024, and ending on May 31, 2025.
