Ensuring that these environments are safe, shaded, and developmentally appropriate is essential to promoting a child's overall well-being and fostering a deep connection with the natural world. At YES For Early Success, we are committed to maintaining outdoor environments that inspire joy, health, and learning for all children.

VISUAL INSPECTION OF OUTDOOR SPACE:

- Inspect outdoor program space for hazards.
- Ensure equipment is free of hazards and in good repair.

☐ Inspector

- Ensure at least 75 square feet of licensed outdoor play space per child accessing the space.
- Verify alternate plans (rotating groups or off-site play areas) are department-approved if needed.

- Verify shaded areas provided by trees, buildings, or shade structures.

AGE-APPROPRIATE PLAY ACTIVITIES:

☐ Inspector

- Ensure play space promotes moderate and vigorous physical activities (running, jumping, etc.).

SAFE ROUTE TO PLAY AREA:

☐ Inspector

- Confirm a safe route to and from the licensed outdoor play space.

FENCING & BARRIERS:

☐ Inspector

- Ensure outdoor play areas are enclosed by fences or barriers to prevent children from exiting.
- Fences should be at least 48 inches high, with gaps no greater than 3.5 inches.

CONDITION OF FENCES & STRUCTURES:

☐ Inspector

- Inspect for good condition of fences, gates, and barriers.
- Ensure no CCA, creosote, or pentachlorophenol-treated wood is used. Test and seal or remove if CCA is present.

PROTECTIVE SURFACING:

☐ Inspector

- Ensure protective surfacing under all play equipment.

☐ Inspector

- Maintain proper fall zones around play equipment.

SWING SPACING & GUARDRAILS:

☐ Inspector

- Ensure swing spacing and guardrails on elevated surfaces are in place.

☐ Inspector

- Check for potential entrapment hazards and ensure no exposed moving parts pose pinch or crush risks.

REPAIRS:

☐ Inspector

- Immediately repair or remove:
- Loose, worn, or hazardous hardware.
- Exposed equipment footings.
- Tripping hazards (debris).
- Rust/chipped paint on metal components.
- Splinters, large cracks, or decayed wood.
- Structural deterioration or corrosion.

EXITS:

☐ Inspector

- Ensure outdoor play areas have two exits, one leading to a non-indoor space.
- Verify that exits are not partially or entirely blocked.

TRANSPORTATION SAFETY:

☐ Inspector

- Maintain up-to-date transportation policy and records.
- File current driver's licenses and vehicle insurance.
- Provide a copy of current driver's license and vehicle insurance.
- Ensure child safety seats and seat belts meet safety requirements.
- Document daily visual vehicle safety checks and regular vehicle inspections.
